## COMMUNITY HEALTH CHECK-UP

On Friday, July 25, 2025, MWPS organized a Women's Health Awareness and Check-up Event at the Al Hilal Hospital Muharraq Branch from 8:30am to 12 noon. The event was designed to support unemployed individuals and those from domestic and low-income backgrounds. In collaboration with Al Hilal Hospital, the initiative provided essential health services including blood pressure and sugar tests, creatinine, SGPT, total cholesterol, and uric acid tests, along with doctor consultations based on test results. A specialist doctor also delivered an awareness talk on women's health. All attendees received Al Hilal Hospital vouchers for free specialist consultations and discounts on additional services. Dry ration packages donated by St. Christopher's School Bahrain were also distributed to participants. As a token of appreciation, Al Hilal Hospital was presented with a memento in recognition of their valuable support for community initiatives.

## IOM-LMRA COMMUNITY DIALOGUE

On Saturday, 26 July 2025, MWPS took part in the Community Majlis organized by the International Organization for Migration (IOM) in collaboration with the Labour Market Regulatory Authority (LMRA) at their Sanabis headquarters. The meeting served as an important platform for dialogue on migrant-related issues, fostering collaborative engagement between stakeholders and community representatives.

MWPS was represented by Vice Chairperson Mrs. Evone Bhaskaran and Assistant General Secretary Mr. Mohammed Gayazullah Amanullah, who actively contributed to discussions aimed at addressing community needs through open dialogue and shared responsibility. This engagement marks a significant step in strengthening community partnerships and advancing constructive dialogue on matters affecting migrant communities.





## OUTREACH



Over the past three months, MWPS covered the cost of seven powers of attorney issued in favour of the lawyer engaged by the organisation. These authorisations supported legal action in cases involving travel bans, unpaid settlements from employers, retrieval of personal belongings from a building manager, and securing relief in an unjustified case filed against a worker by his employer. The following summary highlights some of the most prominent cases from July through September, showcasing the direct impact of our collective work.

### Case 01

A woman from Cameroon arrived in Bahrain on a visit visa in April 2022. Since her arrival, she faced significant challenges, including difficulty securing stable employment, and had to rely on the support of friends and family. Over the past three years, her situation remained precarious, marked by financial instability and declining health. Eventually, she needed to return to Cameroon, but her passport had expired and, being on a visit visa, she was unable to secure assistance for travel expenses. She also lacked a valid travel document. MWPS stepped in to support her by facilitating the issuance of a travel document, clearing her overstay fines, and arranging a one-way flight ticket—enabling her to return home with dignity and peace of mind.

### Case 02

A Sri Lankan national, who was residing in Bahrain for two years and five months was working as a housemaid for one year and one month under extremely difficult conditions, working long hours

daily from 8am to midnight. Her responsibilities included serving her sponsor's family, working for three additional families, and wrapping 300 to 400 sets of cutlery at home for her sponsor's restaurant. She was paid a monthly salary of only BD 150. The sponsor's wife was rude and threatened her once. During her work, she fell twice from the stairs, resulting in difficulty for her to continue working. She requested the sponsor's permission to leave the job and return to Sri Lanka due to her physical condition, but the sponsor refused, withheld her passport, and did not pay her half of her final month's salary. She eventually left the sponsor's home and approached the LMRA to recover her passport. Also, the sponsor had filed a runaway case against her. LMRA directed her to the Sri Lankan Embassy, which in turn referred her to the police station, where she filed a case for passport recovery. Meanwhile the sponsor cancelled her visa making her situation even more difficult. Without a valid visa or passport, she became homeless and unemployed. She approached MWPS and with the support of the authorities, the sponsor handed over the passport to the authorities

### Case 03

A Cameroonian national, arrived in Bahrain on a visit visa but was unable to convert it into a work permit due to legal restrictions. With the assistance of MWPS, he submitted a request to the Cameroonian Embassy for the issuance of the necessary travel document. Once the document was received, MWPS arranged and provided a one-way flight ticket to facilitate his return to Cameroon.

### Case 04

A Nigerian national who had to undergo brain surgery at Salmaniya Medical Complex was discharged but was unable to travel back to her home country immediately, as she required at least two months of rest. Due to the sensitivity of her condition, arrangements were made for her to stay in a shared flat with a volunteer from the local Nigerian community who assisted with her care. MWPS verified the situation and provided essential support by covering her share of the rent for the accommodation and supplying dry ration kits to ensure she had access to basic food items during her recovery.

### Case 05

A Cameroonian national, who was detained, was on an expired flexi visa and had no job, which made him unable to renew his visa. Due to the high cost, and urgency of repatriating him, MWPS reached out to Sri Sathya Sai Global Council who agreed to cover half of the ticket cost and the other half was paid by MWPS.

### Case 06

A Sri Lankan national approached MWPS seeking legal assistance to resolve a travel ban he had been previously unaware of. He discovered the ban when he was stopped at the airport while attempting to travel for vacation. The ban had been imposed by his former landlord due to unpaid room rent. Prior to contacting MWPS, he had paid BD 105 to an agent to verify his status, and was incorrectly informed that no travel ban existed. Unemployed and suffering from dementia, he urgently needed to return to Sri Lanka for medical treatment and family support. He arranged a short-term visa; however, his employer later requested that he either transfer his visa to another sponsor or leave the country. Unable to secure alternative employment, he faced further difficulty when the employer refused to release his passport until he provided a copy of his flight ticket. MWPS intervened to recover his passport and, with the support of the MWPS legal team, successfully lifted the travel ban. MWPS also arranged a one-way flight ticket to facilitate his repatriation.

### Case 07

A domestic worker from India arrived in Bahrain in January 2024 with a valid work permit arranged through an agent to work for a local family. She faced a heavy workload with minimal rest, and after six months, her employment was terminated due to health issues. Following her dismissal, she managed to find part-time work; however, her earnings were insufficient to support herself and her family back home. Without a valid visa or stable employment, she was unable to afford the immigration penalties or the cost of a flight ticket to return to India. She sought assistance from MWPS, which helped her by covering the immigration fine and arranging a one-way flight ticket, enabling her safe and dignified repatriation.

## MWPS RECEIVES AUGUST LOVE OFFERING FROM NEC

In August, the Embrace Ministry of the National Evangelical Church selected MWPS as the beneficiary of their monthly Love Offering, recognizing our organization's community service work. Ayuk Ndumne, Head of the Action Committee, presented MWPS's work during the Friday service on August 1st, while Assistant General Secretary Mohamed Gayaz Ullah delivered a similar briefing on August 3. MWPS newsletters were distributed to congregation members, who contributed donations through the church. The church expressed appreciation for MWPS's ongoing community support, and the collected Love Offering was transferred to our organization to further our humanitarian initiatives.
